# **Brexit**

- ▶ On 29 March 2017 the Prime Minister Theresa May wrote to the President of the European Council Donald Tusk to trigger Article 50 of the Treaty on European Union.
- This sets in motion the two year withdrawal process.
- Maintaining a world class higher education sector is critical to delivering greater progress on the Government's key economic and social goals.
- ► However sector-wide there is recognition that Brexit will bring significant challenges to tertiary education.
- ► There has been a marked absence of sustainability discussion in Brexit discussions so far.

## **UK Political Context**

The last election saw the two main parties in a close fight, one which may lead to a further election in the near future.

Key points from the two main party manifestos are:

#### Conservatives

- Maintain commitment to be the first generation to leave the environment in a better state than they inherited it. They will produce a comprehensive 25 Year Environment Plan that will chart how they will improve our environment as we leave the European Union and take control of our environmental legislation again.
- Work with farmers, food producers and environmental experts across Britain and with the devolved administrations to devise a new agri-environment system, to be introduced in the following parliament. The Conservatives will help Natural England to expand their provision of technical expertise to farmers to deliver environmental improvements on a landscapescale, such as enriching soil fertility, planting hedgerows and building dry stone walls.
- ► The Conservative manifesto does not guarantee environmental protections and standards beyond the point at which the UK leaves the EU.

#### Labour

- the Labour manifesto states that investing in our environment is investing in our future, saying that they will defend and extend existing environmental protections. They state that stewardship of the environment needs to be founded on sound principles and based on scientific assessments.
- ▶ On Brexit, they will replace the Great Repeal Bill with an EU Rights and Protections Bill, which will ensure that there are no detrimental changes to environmental protections as a result of Brexit. Labour state that throughout the Brexit process, they will ensure that all EU-derived laws that are of benefit - including environmental protections - are fully protected without qualifications, limitations or sunset clauses.
- ► A Labour approach to Brexit will ensure there can be no rolling back of key rights and protections and that the UK does not fall behind Europe in, for example, environmental standards in the future.

Both Manifestos provide EAUC members with an opportunity to use their expertise to create opportunities to support environmental commitments.

GuildHE has highlighted four key priorities for Brexit:

- Guaranteeing the current status of non-UK EU staff and students in the UK, and that of UK staff and students based elsewhere in the EU
