Response to the consultation:

We responded to the first DRS consultation in May 2019 and welcome the opportunity to respond to the second consultation.

Introducing a Deposit Return Scheme in England, Wales and Northern Ireland

DRS is a sensible solution in the attempt to lower littering and improve recycling. Our preferred option is Option 2 'all in' model. It is important to make the scheme as straight forward as possible for both retailers and consumers. The infrastructure must be in place to support. Where exemptions to hosting a return point are due to retailers being in close proximity and any compromise of safety, signage should be required to clearly indicate the nearest return point. While we recognise the pandemic has had a major impact we advise against the proposed delay as outlined in the consultation (from 2023 until late 2024 at the earliest). The DRS system in Scotland which will be available from July 2022 should heavily influence a UK-wide DRS system, they must all be able to work together.

Many universities and colleges have already recognised plastic and other single use items for the increasingly problematic issue that they are and are pioneering in their fight against single use products on their campuses. We would encourage the Government to engage with the further and higher education sector to discuss research into plastic alternatives.

We are supportive of the DRS but in face of the climate crisis we are facing a greater emphasis must be placed on removing single use items from the supply chain. Reduction should always be the priority and therefore avoiding single use would be preferable to an improved recycling scheme. However, we recognise that introducing a DRS alongside other reduction measures and policies can play a part in protecting our environment. It is therefore crucial that the scheme is simple and convenient if it is to be effective.

We hope you find this information useful and we would be keen to discuss the role of Further and Higher Education with tackling waste and recycling moving forward.
