- 1. Talking to students on the ground while visiting universities/colleges.
- 2. By collecting data on student opinions e.g. through surveying, polling, online webinars, social media, to inform work happening across the OfS.
- 3. By giving briefings to student representatives across key policy areas.
- 4. By hiring students/recent graduates to work on student facing policy areas.
- 5. The OfS should engage students directly

Q. Why did you rank the engagement activities in question 8 the way you did? Knowing why you ranked the way you did will help the OfS to decide what type of engagement it should prioritise in its approach to student engagement.

A. Talking to students on the ground is the very best engagement activity as it guarantees direct conversations with a broad range of students, but we recognise realistically this will be difficult at scale, and therefore engagement through surveys and Students' Unions is probably the most accessible route. Every effort should be made to prioritise direct conversation though.

**Q.** Is there anything else that the OfS should do to engage students?

A. Of should ensure it is reaching a more diverse and wider breadth of students than it currently does. It is easy to engage with the engaged, but more needs to be done to reach the disengaged. Those that have mental health struggles at university, those at risk of dropping out, those from disadvantaged backgrounds, and those that are put off going to university for various reasons.
