EAUC-Scotland Outcome Agreement with Scottish Funding Council – April 2017- March 2020



UCCCfS: Catalysing Transformative Leadership for Sustainability

Introduction:

The EAUC-Scotland Catalysing Transformative Leadership for Sustainability Programme, running from April 2017 until March 2020, will build upon the previous two Universities and Colleges Climate Commitment for Scotland (UCCCfS) projects. The four Outcomes have been designed to further support Scotland's colleges and universities to develop a skilled and informed, whole-institutional approach to leadership around carbon and resource management, social responsibility and environmental sustainability.

- 1) There is leadership for sustainability at all levels of Scottish FHE Institutions
- 2) The skills and knowledge required to deliver and monitor a low-carbon, sustainable, resilient FHE sector, including improving the accuracy of data in Public Bodies Climate change Duties (PBCCD) carbon reporting, are available throughout the further and higher education sectors.
- 3) Institutions and partners are supported to build cross-organisational and cross-sector contacts, enabling sharing of best practice and development of new solutions to respond proactively to national and international challenges
- 4) Sustainability is embedded into teaching, research and engagement practices in Scottish FHE institutions.

This programme will be delivered by EAUC, working in partnership with individual institutions and strategic partners in Scotland and beyond, to provide a unique level of sustainability support to colleges and universities in Scotland. It will progress the work of both EAUC-Scotland and individual FHE Institutions by strengthening levels of self-sufficiency in addressing sustainability issues, providing long term environmental, social, economic and educational benefits for Scotland and the Scotlish Funding Council.

Definitions:

Outcome Measure: Predetermined results towards which effort is directed, to be achieved by programme end.

Milestone: Scheduled event that indicates the completion of a major deliverable of a project. Milestones are measurable and observable and serve as progress markers.

Deadlines: Programme runs April 2017 to March 2020 (Y1 - Y3) with four quarters ending June (Q1), September (Q2), December (Q3) and March (Q4) annually. All Milestones have deadline of a specific quarter.
